Please complete the [online form](#) for each quilt to be entered in the show. A photo of the maker and each entry must be emailed to Marylee Drake mdrake76@att.net as soon as possible once your application is submitted. If you are unable to send a photo, please contact Marylee at 530-613-4251.

In addition, we are also requesting an abbreviated hard copy form plus a photo, for layout purposes.

All Entries – Guidelines and Procedures:

1. Entries must be (a) quilted, (b) made of fabric, (c) finished, and (d) in good condition.
2. Entries must not have been entered previously in a Foothill Quilters Guild show.
3. Quilts must have a 4" sleeve attached to the top of the back of the quilt. The sleeve should end 1 ½" in from each side of edge of the quilt.
4. Entries must be free of odors and debris.
5. A paper label (provided on the website, to be printed and filled in) must be sewn to the quilt back on the lower right side. Please sew the label inside of garments, and the inside or bottom of bags/totes.
6. Non-judged entries must be hand delivered to Parkside Church, with label and sleeve sewn on, on Thursday, September 17, 2025, between 7:30am and 9:00am.
7. Notify Marylee Drake at 530-613-4251 immediately, if one or more of your entries must be withdrawn from the show, or if you are unable to deliver your quilt at the specified date and time.
8. All entries must be picked up Saturday, September 20, 2025, between 5pm and 6pm at Parkside Church. You must present your receipt to claim your entries.

Judged Entries:

1. Judging will take place at the Veterans Hall, 100 East Street, on Wednesday, September 16, 2025.
2. Judged Entries must be delivered to the Veterans Hall between 8:00 am and 9:00 am on Wednesday, September 16, 2025.
3. Judging fee of \$8 will be collected for each item entered to be judged. Make checks payable to FQG.

4. The judge must be able to view the back of the quilt.
5. Judging will be conducted using the “elimination method”.
6. A scribe will be assigned to each judge who will record comments from the judges. The comments will be returned to the exhibitor at the close of the show.
7. Entries will be judged anonymously.
8. The judging committee reserves the right to move an entry to a different category or return the judging fee if the entry cannot be judged fairly.
9. Judged quilts will be transported to the show location by the Judging committee.

Category Definitions:

- **Art:** Extends beyond the traditional and innovative disciplines, using personal expression and originality in design, color or technique.
- **Applique (Hand or Machine):** Applique predominates over piecing or other techniques in either amount or effect.
- **Bag/Tote:** A bag or tote constructed using fabric and quilting techniques.
- **Challenge:** Quilts made for the 2025 Challenge.
- **Miniature:** Miniature versions of large quilt. All parts of the quilt should be miniature in scale, ie, blocks, borders, binding. Quilts should be no larger than 24”x24”.
- **Modern:** Emphasizes simplicity, minimalism, and/or asymmetrical designs.
- **Pictorial:** Represents a recognizable image of a person, place or thing; may be painted, applique, collage or any number of techniques.
- **Pieced:** Piecing predominates over applique or other technique either in amount or effect.
- **Wearable:** Fashionable and wearable garment constructed using quilting techniques.
- **Other:** Items not covered above - Whole Cloth, Embroidery, Fiber art, etc (describe)
